THE STORY BEHIND THE FLOREX COVER

By Robert H. Goldrn



The recovery of youth, everlasting youth, has always been and still is, one of man's fondest dreams. Hence it is not difficult to imagine the effects it had on the early Spanish explorers when they heard stories of such a fountain with its powers to restore youth, eternal youth, forever.

Juan Ponce de Leon was born about 1460 in the town of San Servace, Province of Leon, as a member of a celebrated family. In boyhood he had been a page to Prince Ferdinand. He evinced such an aptitute for a military career that he was placed under the instruction and guidance of some of the most brilliant army officers of the period. De Leon served as a brave and gallant soldier in Spain's war with the Moors. He fought in many campaigns where he learned the art of war, which was to benefit him later against the Indians.

In 1493, when Columbus fitted out his second expedition to the new world, de Leon was one of the first to volunteer his services, now at the age of 33 years, he was ready for new adventures of a seagoing exploration. Sometime prior to 1502 he returned to Spain and that same year was ordered to Hispanola with Nicolas de Ovando, to be his assistant governor. After their arrival in that colony they found the indians ready to rise up and make trouble. De Leon rendered such capable assistance in the work of pacification of the indians that in 1506, Ovando sent him to administer affairs in the colony at Hayti.

In 1508, De Leon sailed to Puerto Rico to make friends with the natives As was the custom of amity, gifts were exchanged. De Leon was shown the fertile fields abundant with grain and fruit and also where the rivers of the land met - pebbles streaked with GOLD... Subsequent trips were made, with the approval of Governor Ovando, to colonize and garrison the new settlement, San Juan. Spanish rule was set up by 1509 and de Leon became the first governor of Puerto Rico.

GOLD, the word GOLD, caused trouble. Intrigue at the Spanish court, led by Diego Columbus, son of Christopher, reached into the structure of the colony to seek control of Puerto Rico. De Leon was accused of embezzling the King's funds and cheating on the returns of gold to the Spanish crown, plus other charges. Through the intervention of Governor Ovando, who was in Spain at that time, a favorable report on the conduct of de Leon and the merit of his service to the crown, the King let de Leon retain his governorship until such a time the charges would be proved to be true. Later all charges of dishonesty were proven to be false. Gold brought trouble; relations with the indians had changed and were deteriorating to a very bad extent. The indians were now used as forced slave labor to mine the gold, as servants by the officers and for labor on various undertakings. The indian was not free anymore and could not live as he once had.

Spanish soldiers remained and slept under armor as trouble suddenly started at one place then another. But now came an anminous warning as the various tribes began gathering. One day during the troubles, de Leon's assistant governor, Don Cristoval Satomayor, delivered a packet of documents wrapped in oilskin to him with the request that if anything happens to him, de Leon should be guardian of his ward, Donna Inez Satomayor and look to her welfare. Then, as if he had had a premonition, Don Cristoval was ambushed and killed. It was now the year 1511 and e Leon, at the age of 51, was relieved as governor of the colony at Puerto Rico, but he had no worries as he had amassed enough to make him independent. He could now return to Spain and look into the affairs of Donna Inez.

On his arrival at the residence of Don Cristoval, he was introduced to a beautiful young lady. Such beauty in one person was unbelievable. Could it be possible that this was the ward of his old friend and companion in arms, who had asked him to love, cherish and protect her as a father? They met in a warm spontaneous embrace greeting each other. For the next year he stayed at her house - each day meeting and discussing her fortune and future plans for the inheritance. They walked in the garden and supped together and they became closer to each other. Donna Inez as an intelligent, beautiful lady and de Leon as a wonderful, handsome cavalier of awesome experiences.

The King now ordered another expedition to take place.

"Dear Donna Inez tomorrow I shall leave you. I have settled your business as well as I can since I came here. I have learned to love you with all my heart."

Ponce de Leon clasped Donna Inez in his arms and planted a kiss upon her

lips.

"Dear Donna Inez when I leave you it will be for your benefit. I go a man of many years, yet when I return I will be of youth and vigor. That what I seek I have heard of and if I return to you successful, it will be with an honor no other man has ever achieved."

"Go then! and may our Lord protect you in danger, attend you in sickness and health and return you to me to guide and comfort me in years to come. Adios!"

Under the King's orders and grant de Leon sailed from Spain for Puerto Rico, the 23rd of February, 1512. There trouble with the indians delayed him until 1513. He fitted out three ships and taking a northward course he fell in with the Bahamas group of islands. On the 14th of March, he arrived at San Salvador where Columbus had first put his foot on the shores of the new land.

After making a diligent search for the fountain, described by the indians, he failed to find it, but was not discouraged. On he sailed. March 27, 1513 he came in sight of land but could not land because of heavy seas. Looking to the land were tall pines and flowers in abundance. As it was Easter day, the name of the day in the calendar or the fact that many flowers were seen on the coast, the country was named Florida. They landed April 2, probably at St. Augustine to take possession in the name of the King. However, de Leon would make no attempt to settle and explore it until nearly seven years later.

Now whenever de Leon had a chance, he would visit Spain to be near Donna Inez. But the king would always have another grant for him to explore further and no amount of pleading could persuade him to neglect his duty and he would always pledge to her that this would be the last time he would leave her and as always, came talk of the Fountain of Youth. "I am condient it exists. It is one of my highest aspirations to find it. Can I but return to you in strength and vigor with the knowledge and experience that no other man possesses, dear heart! Is this not the prize we week?"

Ponce de Leon was now sixty-one years old and the years were passing fast. This would be the last grant he would accept. He swore an oath to it. He once more left for Puerto Rico where he fitted out two ships and embarked on what was to be his last voyage of exploration to Florida. He landed with a strong body of troops near what is now Charlotte Harbor and advanced inland. They were attacked by hordes of indians and forced to retreat to the ship. In this battle de Leon was struck by an arrow piercing his armor and entering his thigh. The expedition returned to Cuba; the surgeon could not remove the arrow; treatment was of no avail. It was June, the year was 1521 when he died.

In the year 1898, the United States government built a fine tomb in the Dominican Church of Puerto Rico. His epitaph, in Latin, reads: "Beneath this stone reposes the bones of the valiant Lion whose deeds surpassed the greatness of his name."

Donna Inez Satomayor mourned for a few years, later met and married one of Spain's respected noblemen and lived happily ever after.

1945

Reminiscing

I missed FLOREX the past two years. I not only mean I wasn't there, I also mean I really "missed" being there! So am eager to take in '82's version, see what has changed during those two years, and re-establish some old contacts. Some times it's nice to go back, compare notes, see what has occurred in the meantime.

Had the same opportunity last Fall when I went back to Japan for Philatokyo, after being stationed there in 1945-46 for about 8 months. Wouldn't have known it was the same place! Of course, the Imperial Palace and Tokyo Station were in the same places, so I was easily oriented. Went by the building which had been my Company Grade officers' B.O.Q., the home office building of Japan's largest pre-war shipping company, the N.Y.K. Company. It was gone, but on the same spot, finished in 1978, is a beautiful new high rise building which is still the home office for the rejuvanated N.Y.K.

Went by the Dai Ichi Building, which had been the offices for MacArthur's GHQ, and it was intact, unchanged, now again the home office for the Dai Ichi Insurance Company. Walked into the lobby, faced the elevator bank, and immediately burst into laughter. No, I was not the guilty party, but 36 years ago a couple of U.S. officers befriended one of the girl elevator operators. She, like everyone else, knew General MacArthur by sight. So these fellows told her what the perfect salutation was for the General, and had her memorize it in English, though she had no idea what the words meant. The General walked into her elevator one morning, and was greeted by, "Good morning, big, fat American B----d"!

Went by the Imperial Hotel site, which had been flag rank officers' B.O.Q.Razed, and a beautiful new, modern, and enormous Imperial Hotel is on that spot. Wanted to see it, because word had come through that a friend who had been a Light Colonel with me at the Pentagon in about 1943 was on his way to Tokyo --- and as a Brigadier General. Wondered how he had made it so quickly. Two days after he arrived I knew the answer --- what an operator! He had the local black market by the tail! Cigarettes cost us .60 a carton, and brought \$100, and Scotch which was a ration at \$5.00 commanded \$150 and up. I always heard the farmers wound up smoking the cigarettes because they were traded along the line for food, which was scarce and at a premium, but to whom were the farmers going to trade 'em?

But I had one more stop to make: I wanted to see what had been the Dai Iti Hotel, as it was used for Field Grade B.O.Q. Never could locate it, but the memory remained, vividly impressed. We had no hot water or heat in the N.Y.K. Building as all the pipes had been yanked out in the scrap metal drive. Remember, I was there from September through March, and it was cold. Baths in cold water had become a drag when I recognized a familiar name on a GHQ roster sheet - - - a WAC with whom I had graduated from Command and General Staff School at Fort Leavenworth, and she was a Major. That meant she was billeted at the Dai Iti, and I was sure they must have hot water. So I real quick like looked her up, and even faster renewed an old acquaintance. Now don't get me wrong, she had a face like a hot water bottle though she was a nice ole gal, so all I was interested in was her tub! It wasn't long before I was the cleanest Company Grade officer at GHQ! (Having been a G.I. before O.C.S., I remember we called something like this a "field expedient", didn't we?)

So, FLOREX, I'm coming back - - - and I'm positive I'll have a lot of time for stamping and enjoying the show, because I'm sure I won't have to run half way across town for a hot shower!






